Description of the Entity's Outcomes: The Trust currently has three specific aims;
1) Raising funds to be given to the most effective poverty-focused charities; 2) Encouraging & promoting altruism and giving within New Zealand and; 3) Promoting the concept of Effective Altruism in New Zealand. During the reporting period the Trust has been successful in raising funds of \$328,349. It has identified poverty-focused charities where those funds can be most effective and given a total of \$264,489 to those Charities. Further payments totalling \$143,349 were made to those Charities by 11 April 2019. The Trust has developed and implemented various initiatives that promote the awareness of Altruism within New Zealand including a website, giving information talks to various groups, promotional give-aways and conducting research into motivating factors for giving by New Zealanders. It is also further developing its social media presence.
